# UK faces pressure to ban imports linked to Uyghur forced labour in green tech supply chains

LONDON : (AGENCY)

Leading human rights organisations, including Anti-Slavery International, Campaign for Uyghurs, Global Legal Action Network, Stop Uyghur Genocide, Unseen, the Uyghur Human Rights Project (UHRP), and the World Uyghur Congress, have submitted written evidence to the UK Parliament's Foreign Affairs Committee, urging the UK to end its reliance on critical minerals sourced from China's Xinjiang Uyghur Autonomous Region (Uyghur Region), where widespread state-imposed forced labour continues to underpin industrial production. According to the submission, reviewed and cited extensively by the Uyghur Human Rights Project (UHRP), the UK's efforts to diversify supply chains for critical minerals, vital to the green energy transition, must be underpinned by a clear human rights framework. UHRP argues that the production of key minerals, including polysilicon, lithi-



um, manganese, and aluminium, in the Uyghur Region is heavily tied to forced labour and coal-based energy, raising serious ethical and environmental concerns. "The current system props up the Chinese government's apparatus of repression," stated UHRP, warning that companies operating in the Uyghur Region must be presumed complicit in forced labour due to the impossibility of conducting reliable human rights due diligence under the region's

extreme surveillance and coercion. The written evidence highlights how China's state-led Five-Year Plans have deliberately expanded mining and processing industries in the Uyghur Region, where an estimated 1.8 million Uyghurs and other Turkic Muslims have been detained or subjected to forced labour since 2017. UHRP notes that more than 45% of the world's solar-grade polysilicon now comes from this region, with major solar manufac-

turers linked to labour transfer schemes. Electric vehicle supply chains are similarly exposed. China now processes 44% of the world's lithium chemicals and dominates production of key battery components. UHRP cites findings that implicate lithium and manganese producers in state-sponsored labour transfers, warning that most EV battery supply chains are tainted by Uyghur forced labour. Aluminium and steel production also raise red flags.

UHRP reports that nearly 12% of global aluminium production capacity is located in the Uyghur Region, with major smelters involved in labour transfer schemes.

This concentration, paired with artificially low costs enabled by coal power and forced labour, distorts global markets and undermines ethical producers, the submission says. UHRP calls on the UK government to introduce legislation banning the import of goods made with forced labour and align with allies like the US.

, which passed the Uyghur Forced Labor Prevention Act (UFLPA) in 2021. "Without legislative teeth, the UK risks embedding atrocity crimes in its renewable energy and manufacturing supply chains," UHRP warns. The submission concludes with a call for the UK to lead on a "just transition" that prioritises both climate and human rights goals by building transparent, ethical, and resilient supply chains free from Uyghur forced labour.

FRANKFURT : (AGENCY)

Shafi Burfat, the Chairman of the Jeay Sindh Muttahida Mahaz (JSMM), has accused the Punjabi military establishment and Pakistan's intelligence agency ISI of systematically executing a plot to incite ethnic conflict in Sindh. He claimed that the military and its affiliates are exploiting social media to instigate divisions between Sindhi-speaking and Urdu-speaking populations, thereby weakening Sindh's national unity and jeopardising its emerging freedom struggle. Burfat asserted that these online conflicts are not mere coincidences but are instead intentional campaigns driven by a longstanding agenda. He noted the resurgence of divisive speech on social media platforms, which, according to him, is disseminated by state actors posing as ordinary citizens or military personnel in disguise. He believes these operations aim to incite



hatred, mislead the youth, and undermine the solidarity needed for Sindh's political emancipation. He mentioned individuals like Afaq Ahmed, an Urdu-speaking politician, accusing him of having worked with the military in the past during operations that resulted in the deaths of numerous Urdu-speaking youth in Karachi. Burfat contends that such figures are now re-emerging to promote harmful anti-Sindh narratives online. Simultaneously, he cautioned that some individuals who speak Sindhi, while responding

emotionally to these provocations, are unintentionally assisting these state-driven schemes. Burfat emphasised that linguistic, ethnic, or religious identities should not separate the people of Sindh. He reiterated that everyone residing in Sindh, regardless of whether they speak Sindhi, Urdu, Saraiki, Balochi, Pashto, Punjabi, Brahui, Dhatki, Kutchi, Memoni, or Lasi, constitutes one Sindhi nation. He stressed that both Hindus and Muslims, as well as Shias and Sunnis, are united by their connection to Sindh and share mutual political, economic, and cultural interests. He portrayed Sindh not merely as territory but as one of the world's oldest civilisations, the birthplace of the Indus Valley Civilisation, insisting that all communities within its borders are its rightful heirs. He expressed sorrow that within what he referred to as an "unnatural state" like Pakistan.

## Pakistan Army chief Munir expected to visit US again : Report

ISLAMABAD : (AGENCY)

Pakistan Army chief Asim Munir is expected to visit the US this week for consultations with top American officials, his second trip to Washington since the four-day conflict with India, a media report said on Thursday. In June, Munir travelled to the US on a rare five-day trip during which he attended a private luncheon with President Donald Trump. That meeting culminated in Trump's announcement of enhanced US-Pakistan cooperation in various fields, including an oil deal. Field Marshal Munir is expected in the US this week for consultations with his American counterparts, Dawn newspaper reported, citing official sources. Sources told the paper that this would be a return visit, following a trip to Pakistan by Gen. Michael Erik Kurilla, head of the US Central Command (CENTCOM), in late July. In a press statement issued on August 4, CENTCOM recalled Gen Kurilla's recent visit to Pakistan and other countries in the region. During the visit, Gen Kurilla was also conferred the Nishan-i-Imtiaz (Military) by the Pakistani government. During his previous visit to Washington, Munir was hosted by President Trump in an unprecedented ges-



ture typically reserved for visiting heads of state or government. There was no official word on the visit from Inter-Services Public Relations or Pakistan's embassy in Washington, but during his previous visit, the army chief had hinted that he expected to return to the US again later in the year. The development comes just over a month after the US general described Pakistan as a "phenomenal partner" in counterterrorism efforts during a congressional hearing, where he also praised Pakistan's role "in promoting peace and stability" in the region. After his meeting with Trump in June, Munir had held a comprehensive and candid exchange with senior scholars, analysts, policy experts, and representatives of leading international media outlets in Washington. His visit to the US came weeks after the four-day conflict between India and Pakistan following the April 22 Pahalgam terror attack.

## United Airlines' tech outage grounds flights nationwide; delays ripple through global routes

HOUSTON : (AGENCY)

More than 800 United Airlines flights were cancelled and hundreds more delayed by late Wednesday



following a major technology outage that forced a system-wide ground stop across the United States, severely disrupting both domestic and international travel. At Houston's George Bush Intercontinental Airport (IAH), where United operates a key hub, long lines and frustrated passengers filled terminals. The airline traced the outage to failures in its dispatch and fuelling systems. "Due to a technology issue, we are holding United mainline flights at United departure airports," United said in a statement. "We expect additional flight delays this evening as we work through this issue." The (FAA) confirmed that the grounding was initiated

by United and shared an official statement on social media: "United Airlines requested the FAA to pause its departures nationwide while they addressed a technology issue. The FAA is monitoring the situation closely." Among those affected was Ishya, a young professional from New York scheduled to return to LaGuardia Airport after a brief family visit in Houston. "This visit home was my little reset and now, it is turning into an unplanned extension," she said, watching the departure board. "Even the staff does not have answers. It is nerve-wracking." Another passenger, Michael Tran, a software engineer, travelling to Tokyo, via San Francisco, expressed his frustration. "I had meetings lined up in Tokyo -- now I am stuck here with no idea when I will get out. Even the staff seems overwhelmed," he said. The outage affected United's global network as well. Flights from Newark and Chicago to Delhi and Mumbai were delayed by several hours, complicating onward connections for passengers from cities.

# Pak made us its permanent enemy using terrorism as its weapon : MJ Akbar

ISLAMABAD : (AGENCY)

Former MoS for External Affairs, MJ Akbar on Thursday said that no country has a permanent enemy but Pakistan made India one through terrorism. "There very few countries. I mean, we are not permanent enemies with anyone. Pakistan has made us its permanent enemy using the terrorism as its only weapon. But that's an unusual factor for different reasons," he said in conversation with ANI. He said that US President Donald Trump's favouritism towards Pakistan has damaged the bilateral ties between US and India.

Akbar said that it was



strange of Trump to 'woo' Pakistan Field Marshal Asim Munir even after he spoke inflammatory comments ahead of the April 22 Pahalgam terror attack. "Trump's this move, especially when talking about Pakistan, they have destroyed the two decades of efforts made by the political classes of both the sides. What has been built so carefully cannot be

destroyed so suddenly. But, yes, it would be very foolish to pretend that there has been no damage. I think in particular, President Trump's very strange sort of wooing of the most fundamentalist elements in the Pakistan establishment, which is its military and its army chief," he said Akbar that the US must stop its policy of two rules- one for itself and the other for the world. "Don't forget this is the same army chief of Pakistan, General Munir, who has introduced the doctrine of supremacism and fascism and religion-based fascism in his famous speech. Has President Trump's staff not shown him that speech? Not

shown him what he said? He has been the architect of what is nothing less than ethnic cleansing. Over and over again, I find that America tends to exercise now the theory of two laws, one law for itself.

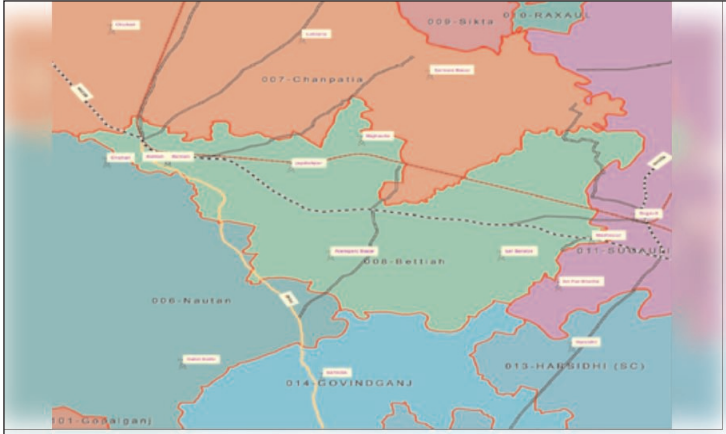


# बिहार चुनाव : बेतिया विधानसभा सीट पर टिकीं निगाहें, ऐतिहासिक और राजनीतिक दृष्टि से बेहद अहम

**पटना (एजेंसी)**

बिहार विधानसभा चुनाव को लेकर राजनीतिक गतिविधियों ने गति पकड़ ली है। सभी प्रमुख दल अपनी तैयारियों में जुटे हैं और पश्चिमी चंपारण जिले की बेतिया विधानसभा सीट पर सबकी नजरे टिकी हुई हैं। फिलहाल इस सीट पर भारतीय जनता पार्टी (भाजपा) का दबदबा है। बेतिया विधानसभा क्षेत्र बिहार के पश्चिमी चंपारण जिले के साथ-साथ महौलिया प्रखंड की 18 पंचायतें शामिल हैं।

2024 के प्रोजेक्टेड आंकड़ों के अनुसार बेतिया की कुल जनसंख्या लगभग 4.92 लाख है, जिसमें पुरुषों की संख्या 2,58,925 और महिलाओं की संख्या 2,33,100 है। भारत निर्वाचन आयोग के अनुसार 1 जनवरी 2024 की स्थिति में इस क्षेत्र में कुल 2,90,244 मतदाता दर्ज हैं, जिनमें 1,53,120 पुरुष और 1,37,119 महिला मतदाता शामिल हैं। राजनीतिक रूप से बेतिया विधानसभा सीट का इतिहास दिलचस्प रहा है। 1951 में स्थापित इस सीट पर अब तक 18



चुनाव हो चुके हैं। शुरुआती दौर में यह सीट कांग्रेस के कब्जे में रही और 1952 से 1985 के बीच हुए 10 चुनावों में से 9 में पार्टी ने जीत हासिल की। भाजपा ने 1990 में इस सीट पर चुनाव लड़ना शुरू किया और अब तक 6 बार विजयी रही है। पार्टी को सिर्फ 1995 और 2015 में मामूली अंतर से हार का सामना करना पड़ा। भाजपा की वरिष्ठ नेता और पूर्व उपमुख्यमंत्री रणु देवी इस सीट से अब तक पांच बार विधायक रह चुकी हैं। उनकी पकड़

यहां खासकर महिला मतदाताओं और संगठित भाजपा कैडर के कारण मजबूत मानी जाती है। कांग्रेस की ओर से गौरी शंकर पांडे ने चार बार और जय नारायण प्रसाद ने दो बार इस सीट पर जीत दर्ज की। हाल के वर्षों में भाजपा का प्रभाव और भी बढ़ा है।

राजनीतिक समीकरणों के साथ-साथ बेतिया का ऐतिहासिक और सांस्कृतिक महत्व भी इसे एक पहचान देता है। यह शहर न सिर्फ बेतिया राज की ऐतिहासिक रियासत का केंद्र

मुठभेड़ में ढेर हो गए हैं। इन पर एक-एक लाख का इनाम रखा गया था। नोएडा एसडीएम से मिली जानकारी के मुताबिक बीती रात यूपी एसटीएफ की नोएडा यूनिट और सीतापुर पुलिस की संयुक्त कार्रवाई में थाना पिसावां क्षेत्र में एक बड़ी सफलता हाथ लगी।

पुलिस और बदमाशों के बीच हुई मुठभेड़ में दो कुख्यात इनामी बदमाश गोली लगने से गंभीर रूप से घायल हो गए, जिन्हें उपचार के लिए तत्काल

रिजवान (पुत्र कृष्ण गोपाल उर्फ करीम खान, निवासी अटवा, थाना मिसरिया) और संजय तिवारी उर्फ शिबू उर्फ शकील खान (पुत्र कृष्ण गोपाल उर्फ करीम खान, निवासी अटवा, थाना मिसरिया) जनपद सीतापुर के रूप में हुई है।

दोनों बदमाश सीतापुर में पत्रकार राघवेंद्र वाजपेयी की हत्या के मामले में वांछित थे और इन पर एक-एक लाख रुपये का इनाम घोषित था। पुलिस

रिकॉर्ड के अनुसार, राजू तिवारी उर्फ रिजवान वर्ष 2006 में जनपद लखीमपुर खीरी के थाना क्षेत्र में तैनात उपनिरीक्षक परवेज अली की धारदार हथियार से हत्या कर चुका था और उसकी सकारी रिवॉल्वर भी लूट ली थी। वहीं, संजय तिवारी उर्फ शकील खान ने वर्ष 2011 में देवी सहाय शुक्ल (थाना मचरहेता, सीतापुर) की गोली मारकर हत्या कर दी थी।

इन दोनों पर हत्या, लूट, डकैती सहित दो दर्जन से अधिक गंभीर आपराधिक मुकदमे दर्ज हैं। ये लंबे समय से फरार चल रहे थे और पुलिस के लिए चुनौती बने हुए थे।

अधिकारियों ने बताया कि इन अपराधियों की धरपकड़ के लिए लगातार प्रयास किए जा रहे थे और गुप्त सूचना के आधार पर कार्रवाई करते हुए मुठभेड़ को अंजाम दिया गया। पुलिस अब इस केस से जुड़े अन्य पहलुओं की भी जांच कर रही है ताकि हत्या की साजिश से जुड़े बाकी पहलुओं का भी खुलासा किया जा सके।

कि अखिलेश यादव ने मीडिया से बातचीत करते हुए कहा था कि यह हजारों साल पुरानी लड़ाई है, एक कोई मनु महाराज आए थे, जिन्होंने गड़बड़ कर दी, जिनकी वजह से हम लोग बंट गए। वहीं, सपा सांसद अखिलेश यादव की पत्नी डिंपल यादव पर मौलाना साजिद रशीदी के दिए विवादित बयान पर जगतगुरु रामभद्राचार्य ने प्रतिक्रिया देने से इनकार किया। हालांकि, उन्होंने कहा कि मैं इन सब प्रकरण में नहीं पड़ता हूं। जगद्गुरु रामभद्राचार्य ने कहा कि मेरा इस विषय में बोलना उचित नहीं है, क्योंकि मेरा अपना एक पद है। मैं जगतगुरु और पद्म विभूषण भी हूं। मैं इन छेटी-छेटी बातों पर चर्चा नहीं करना चाहता हूं। समाजवादी पार्टी की सांसद डिंपल यादव पर एक टीवी शो के दौरान मौलाना साजिद रशीदी ने आपत्तिजनक टिप्पणी की थी। उनकी टिप्पणी का वीडियो सोशल मीडिया पर वायरल हो गया था। वहीं, इस टिप्पणी को लेकर रशीदी पर युवकों ने हमला भी किया था, जिसे लेकर एफआईआर दर्ज कराई गई थी।

## धनबाद का कुख्यात गैंगस्टर आशीष रंजन प्रयागराज में ढेर, एके - 47 समेत कई हथियार जब्त

**प्रयागराज (एजेंसी)**

झारखंड का धनबाद निवासी कुख्यात गैंगस्टर आशीष रंजन सिंह उर्फ छोटू सिंह यूपी के प्रयागराज में एसटीएफ के साथ मुठभेड़ में मारा गया है। मुठभेड़ प्रयागराज के शंकरगढ़ इलाके में बुधवार देर रात हुई। पुलिस की गोली से घायल आशीष को अस्पताल पहुंचाया गया था, जहां इलाज के दौरान उसने दम तोड़ दिया। झारखंड पुलिस के एक वरिष्ठ अधिकारी ने भी आशीष रंजन की मौत की पुष्टि की है। एसटीएफ को मिली गुप्त सूचना के आधार पर यह कार्रवाई की गई थी। इनपुट मिला था कि आशीष अपने एक सहयोगी के साथ प्रयागराज में किसी बड़ी आपराधिक वास्तुत को अंजाम देने की फ़िराक में हैं। यह भी बताया गया कि वह शिवराजपुर चौगछा, थाना शंकरगढ़ के रास्ते शहर में दाखिल होने वाला है। इस सूचना के बाद एसटीएफ प्रयागराज की टीम ने इलाके में घेराबंदी कर दी। जैसे ही आशीष वहां पहुंचा, पुलिस ने उसे



घेरने की कोशिश की, लेकिन उसने आत्मसमर्पण करने के बजाय एके-47 राइफल और 9 एएमएम पिस्टल से अंधाधुंध फायरिंग शुरू कर दी।

इस हमले में एसटीएफ के तीन जवान बाल-बाल बचे। पुलिस ने जवाबी फायरिंग की, जिसमें आशीष बुग़ी तरह घायल हो गया। आशीष को तत्काल अस्पताल ले जाया गया, जहां उसकी मौत हो गई। मौके से एक एके-47 राइफल, एक 9 एएमएम पिस्टल, बड़ी संख्या में जिंदा कारतूस और खाली खोखे के अलावा एक मोटरसाइकिल बरामद की गई है।

ब्रामद हथियारों की फॉरेंसिक जांच शुरू कर दी गई है। आशीष रंजन धनबाद के जैसी मल्लिक रोड का निवासी था और झारखंड सहित कई राज्यों में दर्ज संगीन आपराधिक मामलों में वांछित था। धनबाद मंडल कारा में 3 दिसंबर 2023 को हुए चर्चित गैंगस्टर अमन सिंह हत्याकांड में भी आशीष रंजन का नाम प्रमुख साजिशकर्ता के रूप में सामने आया था। सीआईडी की जांच में खुलासा हुआ था कि आशीष के इशारे पर जेल के भीतर गैंगस्टर अमन सिंह की हत्या सुंदर यादव उर्फ रितिश यादव ने की थी।

## सहरसा के स्कूल कैंपस में मिला आठवीं के छात्र का शव, परिजनों ने स्कूल प्रशासन पर हत्या का आरोप लगाया

**सहरसा (एजेंसी)** जिले के बनगांव थाना क्षेत्र अंतर्गत चैनपुर स्थित शशिकला मध्य विद्यालय में उस समय हड़कंप मच गया, जब स्कूल कैंपस के पास एक 12 वर्षीय छात्र का शव बरामद किया गया। मृतक की पहचान बिट्टू कुमार के रूप में हुई है, जो उसी स्कूल में आठवीं कक्षा का छात्र था और बीते दिन से लापता था। मंगलवार की सुबह जैसे ही स्कूल खुला, आसपास के लोगों की नजर स्कूल से सटी गली में पड़े एक शव पर पड़ी। शव की



पहचान बिट्टू कुमार के रूप में होते ही इलाके में सनसनी फैल गई। देखते ही देखते स्थानीय ज़िलेग और परिजन स्कूल पहुंच गए और स्कूल प्रशासन पर लापरवाही का आरोप लगाते हुए घेराव करने लगे। मृतक छात्र के पिता का कहना है कि बिट्टू सोमवार को

स्कूल गया था, लेकिन शाम तक घर नहीं लौटा, जिसके बाद परिजनों ने चारों ओर तलाश शुरू की, लेकिन कोई सुरांग नहीं मिला। मंगलवार सुबह जब स्कूल खुला, तो छात्र का शव स्कूल के बगल वाली गली में संदिग्ध स्थिति में पड़ा मिला, और हाथ में जलने के निशान भी पाए गए।

परिजनों का आरोप है कि यह कोई सामान्य हादसा नहीं, बल्कि पूर्व नियोजित हत्या है, जिसमें स्कूल प्रशासन की लापरवाही या सहिष्णुता की भी जांच होनी चाहिए। वहीं स्कूल के एक शिक्षक ने कहा कि बिट्टू सोमवार को स्कूल आया जरूर था, लेकिन स्कूल की छुट्टी के बाद सभी बच्चे और शिक्षक अपने-अपने घर चले गए।
